04/24	<b>Motion:</b> To receive the results of the residents parking survey and make a recommendation to Full Council about the LCC car park opposite St Catwg's church.	
05/24	<b>Motion:</b> to write to St Catwg's Church, asking them to implement a car sharing scheme among their congregation, if one is not already in place, in order to ease pressure in the car park, particularly at weekends.	
	<b>Motion:</b> To consider whether to pay for additional enforcement of existing on-street parking restrictions at a cost of £8,325 startup costs in the first year + £300 a day + mileage. The setup costs would add £13.88 to our 'bit' of the Council tax for a band D household with ongoing costs adding around another £2-3 per year. To make a recommendation to Full Council.
